安全规章

电动工具通用安全警告

不遵照以下所列说明会导致电击、着火和/或严重伤害。

保存所有警告和说明书以备查阅。

警告中的术语"电动工具"是指市电驱动(有线)电动工具或电池驱动(无线)电动工具。

工作场地的安全

- ▶ 保持工作场地清洁和明亮。杂乱和黑暗的场地会引发事故。
- ► 不要在易爆环境,如有易燃液体、气体或粉尘的 环境下操作电动工具。
 电动工具产生的火花会点燃粉尘或气体。
- ▶ 操作电动工具时,远离儿童和旁观者。注意力不 集中会使你失去对工具的控制。

电气安全

- ▶ 电动工具插头必须与插座相配。绝不能以任何方式改装插头。需接地的电动工具不能使用任何转换插头。未经改装的插头和相配的插座将降低电击风险。
- ▶ 避免人体接触接地表面,如管道、散热片和冰箱。如果你身体接触接地表面会增加电击风险。
- ▶ 不得将电动工具暴露在雨中或潮湿环境中。水进入电动工具将增加电击风险。
- ▶ 不得滥用软线。绝不能用软线搬运、拉动电动工具或拔出其插头。使软线远离热源、油、锐边或运动部件。受损或缠绕的软线会增加电击风险。
- ▶ 当在户外使用电动工具时,使用适合户外使用的 延长线。适合户外使用的电线将降低电击风险。
- ▶ 如果无法避免在潮湿的环境中操作电动工具,应使用带有剩余电流装置(RCD)保护的电源。
 RCD的使用可降低电击风险。

人身安全

- ▶ 保持警觉,当操作电动工具时关注所从事的操作 并保持清醒。当你感到疲倦,或在有药物、酒精 或治疗反应时,不要操作电动工具。在操作电动 工具时瞬间的疏忽会导致严重人身伤害。
- ▶ 使用个人防护装置。始终佩戴护目镜。防护装置,诸如适当条件下使用防尘面具、防滑安全鞋、安全帽、听力防护等装置能减少人身伤害。
- ▶ 防止意外起动。在连接电源和/或电池包、拿起或搬运工具前确保开关处于关断位置。手指放在开关上搬运工具或开关处于接通时通电会导致危险。
- ▶ 在电动工具接通之前,拿掉所有调节钥匙或扳 手。遗留在电动工具旋转零件上的扳手或钥匙会 导致人身伤害。

- ▶ 手不要过分伸展。时刻注意立足点和身体平衡。 这样能在意外情况下能更好地控制住电动工具。
- ▶ 着装适当。不要穿宽松衣服或佩戴饰品。让你的 头发和衣服远离运动部件。宽松衣服、佩饰或长 发可能会卷入运动部件。
- ▶ 如果提供了与排屑、集尘设备连接用的装置,要确保其连接完好且使用得当。使用集尘装置可降低尘屑引起的危险。
- ► 不要因为频繁使用工具而产生的熟悉感而掉以轻心,忽视工具的安全准则。某个粗心的动作可能在瞬间导致严重的伤害。

电动工具使用和注意事项

- ▼ 不要勉强使用电动工具,根据用途使用合适的电动工具。选用合适的按照额定值设计的电动工具会使你工作更有效、更安全。
- ▶ 如果开关不能接通或关断电源,则不能使用该电动工具。不能通过开关来控制的电动工具是危险的日必须进行修理。
- ► 在进行任何调节、更换附件或贮存电动工具之前,必须从电源上拔掉插头和/或卸下电池包(如可拆卸)。这种防护性的安全措施降低了电动工具意外起动的风险。

电池式工具使用和注意事项

- ▶ 当电池包不用时,将它远离其他金属物体,例如 回形针、硬币、钥匙、钉子、螺钉或其他小金属 物体,以防电池包一端与另一端连接。电池组端 部短路可能会引起燃烧或着火。
- ► 在滥用条件下,液体可能会从电池组中溅出;应 避免接触。如果意外碰到液体,用水冲洗。如果 液体碰到了眼睛,还应寻求医疗帮助。从电池中 溅出的液体可能会发生腐蚀或燃烧。

维修

- ▶ 注意火灾危险! 应避免磨料和研磨机过热。每次工作休息前都要清空集尘腔。集尘袋、微过滤器、纸袋(或者吸尘器的过滤袋或过滤器)内的磨削粉尘可能会在不良条件下(例如研磨金属时火花飞溅)被点燃。如果磨削粉尘与油漆或聚氨酯残余物或者其他化学原料混合,且磨料在长时间作业后产生高温时,会产生极大危险。
- ▶ 定期清洁电动工具的通风间隙。电动机风扇会将 灰尘吸进机壳,过多的金属粉末沉积会导致电气 危险。

充电电池

Bosch也销售不带充电电池的充电式电动工具。您可以在包装上查看电动工具的供货范围内是否包含充电电池。

为充电电池充电

▶ 请只使用在技术参数中列出的充电器。只有这些充电器才适用于本电动工具上的锂离子电池。

提示: 鉴于国际运输规定, 锂离子充电电池在交货时只完成部分充电。首度使用电动工具之前, 必须 先充足充电电池的电以确保充电电池的功率。

安装充电电池

将充好电的充电电池推入电池座, 直到嵌入。

取出充电电池

如需取下充电电池,则请按压解锁按钮,然后拔出 充电电池。**在此过程中请勿过度用力。**

充电电池具备双重锁定功能,即使不小心触动了充电电池的解锁按钮,充电电池也不会从机器中掉落下来。只要充电电池安装在电动工具中,就会被弹簧固定在其位置上。

充电电池电量指示灯

提示:并非每种充电电池型号均具备电量指示灯。 充电电池电量指示灯的绿色LED灯显示充电电池的 电量。基于安全原因,只能在电动工具静止时检查 充电电池的电量。

按压充电电量指示灯按键◎或配,来显示充电电量。也可以在充电电池取下时操作。

如果按压充电电量指示灯按键后没有LED灯亮起,则说明充电电池损坏,必须进行更换。

充电电池损坏风险识别

EXPERT18V... | EXBA18V...

充电电池电量指示灯的LED除了可以显示充电电池 电量之外,还可以显示充电电池损坏的风险。

如需激活该功能,按住电量指示灯**∞**按钮3秒钟。充电电池的分析通过充电电池电量指示灯顺序发光来显示。结果以充电电池电量指示灯显示。

1个LED: 充电电池的损坏风险较高。功率和运行时间可能已经降低。建议更换充电电池。

5个LED: 充电电池处于良好状态,损坏风险较低。

请注意: 充电电池损坏风险评估功能分两档运行, 提供简单的状态评价。充电电池要么被评价为状态 良好,要么就是具有较高的损坏风险。不显示电池 状态的百分比。

如何正确地使用充电电池

保护充电电池,避免湿气和水分渗入。

充电电池必须储存在-20°C至50°C的环境中。夏天不得将充电电池搁置在汽车中。

不定时地使用柔软,清洁而且乾燥的毛刷清洁充电 电池的通气孔。

充电后如果充电电池的使用时间明显缩短,代表充电电池已经损坏,必须更换新的充电电池。 请注意有关作废处理的规定。

安装

▶ 对电动工具执行任何操作(比如保养、更换刀具等)前需将充电电池从电动工具中取出。意外操作起停开关可能会造成伤害。

更换磨板 (见图片F)

可根据需求更换磨板(8)。

小心地旋出4个螺栓**(12)**,然后取下磨板**(8)**。装上 新磨板**(8)**,然后重新拧紧螺栓。

更换砂纸

装入新砂纸前,用刷子清除磨板**(8)**上的脏污和灰尘。

注意将砂纸的冲孔与磨板上的孔重叠,以确保最佳的集尘效果。

带魔术贴的砂纸 (见图片A)

如果磨板**(8)**带有尼龙织物,则可通过魔术贴快速便 捷地固定砂纸。

装入砂纸**(9)**前,请先敲出磨板**(8)**的尼龙织物,以便实现最佳粘合效果。

将砂纸**(9)**紧贴磨板**(8)**一侧,然后将砂纸放到磨板上并压紧。

如需取下砂纸(9),请抓住顶部,然后从磨板(8)上取下。

不带魔术贴的砂纸 (参见插图B-D)

- 将两个卡箍(7)从止动件中松开,然后将其向下翻转。
- 将砂纸(9)插入后部夹条(6)下方。确保砂纸(9) 不要太短并正确夹紧。将卡箍(7)翻转回初始位 置并将其锁止在那里。
- 将砂纸紧绷地铺在磨板(8)上。将砂纸前部夹紧在前部夹条(10)下方。确保砂纸(9)不要太短并正确夹紧。将卡箍(7)翻转回初始位置并将其锁止在那里。

无孔砂纸,比如整卷或整米卖的砂纸,可以用穿孔工具(17)为其打孔,以便能够吸尘。为此,请将已安装好砂纸的电动工具压到穿孔工具上(见图片 E)。

要取下砂纸(**9**),松开两个卡箍(**7**),然后将砂纸从 其底座中取出。

吸锯尘/吸锯屑

在没有采取减尘措施的情况下避免作业。

合适的集尘装置或集尘盒/集尘袋可减少有害健康的粉尘污染。工作场地要保持空气流通。原则上要使用合适的呼吸面罩。为确保最佳集尘效果,请在使用集尘盒时及时清空该盒并定期清洁滤芯。

将集尘软管(16)插到吸尘器转换接口(13)上。

将集尘软管**(16)**与吸尘器连接。在本使用说明的末 尾可以找到各种集尘器的连接概览。

根据工件的物料选择合适的吸尘装置。

吸集可能危害健康,可能导致癌症或干燥的废尘 时,务必使用特殊的吸尘装置。

在垂直的平面上操作电动工具时,必须以吸管朝下的方式握持电动工具。

利用集尘盒自集尘 (参见插图G-I)

放上集尘袋总成(2)并套到吸尘器转换接口(13)上, 直到与工具平齐。

要排空集尘袋(14),将集尘袋总成(2)从吸尘器转换接口(13)上拉下来。将适配接口(15)从集尘袋(14)上拧下 ① 并排空集尘袋。

提示:为了确保最佳吸尘效果,请及时排空集尘袋 **(14)**。

在垂直的平面上工作时,必须以集尘袋**(2)**朝下的方式握持电动工具。




